Invitation to Bid for

DEVELOPMENT OF NEW DEEP WELL SOURCE (2ND PHASE)

- 1. The **TUBOD-BAROY WATER DISTRICT**, through the **CORPORATE OPERATING BUDGET**, intends to apply the sum of **ONE MILLION SEVEN HUNDRED FIFTY THOUSAND PESOS (PHP 1,750,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Development of New Deep Well Source (2nd Phase)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The TUBOD-BAROY WATER DISTRICT invites bids for the Development of New Deep Well Source (2nd Phase). Completion of the Works is required within thirty (30) calendar days. The prospective Bidder must have an experience of having completed at least one (1) contract that is similar to the contract to be bid and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4. Interested bidders may obtain further information from Tubod-Baroy Water District BAC Secretariat and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm weekdays.
- 5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **FIVE THOUSAND PESOS ONLY** (**PHP 5,000.00**).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), <u>www.philgeps.net</u> and the website of Tubod-Baroy Water District, <u>www.tbwd.gov.ph</u>, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

- 6. Tubod- Baroy Water District will conduct a pre-qualification of Eligibility Documents on <u>August 21, 2020</u>, <u>10:00am</u> at <u>TBWD Office.</u> Late documents shall not be accepted.
- 7. The Tubod Baroy Water District will hold a Pre-Bid Conference on <u>August 25, 2020</u> at <u>2:00</u> pm at the <u>TBWD</u> <u>Office</u> for eligible supplier who passed the pre-qualification.
- 8. Bids must be delivered to the address below on or before <u>10:00 am</u> of <u>September 7, 2020</u> at <u>TBWD Office</u>. <u>All</u> <u>bids must be accompanied by a bid security in any of the acceptable forms and in the amount</u> <u>stated in ITB Clause 18</u>.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

Bid Evaluation shall be on September 7, 2020 at 2:00 pm at TBWD Office **Post Qualification** shall be on September 9, 2020 at 2:00 pm at TBWD Office **Approval of Resolution/Issuance of Notice of Award** shall be on September 10, 2020 at 2:00 pm at TBWD Office.
