### INVITATION TO BID

#### **SUPPLY , DELIVERY, INSTALLATION AND COMMISSIONING OF FULLY AUTOMATIC ADVANCED CATALYTIC MEDIA MULTI LAYER FILTER SYSTEM**

The TUBOD-BAROY WATER DISTRICT, through the **CORPORATE OPERATING BUDGET** intends to apply the sum of **SEVEN MILLION TWO HUNDRED THOUSAND PESOS (7,200,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract payable within 3 years after commissioning (monthly installment) payable for **FULLY AUTOMATIC ADVANCED CATALYTIC MEDIA MULTI LAYER FILTER SYSTEM**. Bids received in excess of the ABC shall automatically rejected at bid opening.

1. The TUBOD-BAROY WATER DISTRICT now invites bids for **SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF FULLY AUTOMATIC ADVANCED CATALYTIC MEDIA MULTI LAYER FILTER SYSTEM**. Delivery of the Goods is required **45 DAYS**.
2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
3. Interested bidders may obtain further information from TUBOD-BAROY WATER DISTRICT and inspect the Bidding documents at the address given below during **Mondays to Fridays 8:00AM-5:00PM**.
4. A complete set of Bidding Documents may be purchased by interested Bidders on **February 22, 2022** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Ten Thousand Pesos (10,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of Tubod-Baroy Water District, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

5. The TUBOD-BAROY WATER DISTRICT will hold a Pre-Bid conference on **10:30 AM March 2, 2022** at **Tubod-Baroy Water District Office, Sagadan, Tubod, Lanao del Norte**, which shall be open only to all interested parties who have purchased the Bidding Documents.
6. Bid must be delivered to the address below on or before **March 14, 2022**. All Bids must be accompanied by a **bid security** in any of the acceptable forms and in the amount stated in ITB.

Bid opening shall be on **March 14, 2022 at 10:30 in the morning** at **Tubod-Baroy Water District Office**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

**Bid Evaluation** shall be on March 15, 2022 at 2:00 o'clock in the afternoon at TBWD Office  
**Post-qualification** shall be on March 16, 2022 at 2:00 o'clock in the afternoon at TBWD Office  
**Approval of Resolution/Issuance of Notice of Award** shall be on March 17, 2022 at 3:00 o'clock in the afternoon at TBWD Office.

7. The TUBOD-BAROY WATER DISTRICT reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
