2. The TUBOD-BAROY WATER DISTRICT now invites bids for 2nd PHASE OF TBWD CLUSTERING PROJECT Delivery of the Goods is required 20 DAYS for the initial delivery and will have a schedule delivery dates.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
